CALL FOR SUBMISSION OF THE ANNUAL BLACK BUSINESS GROWTH FUND (BBGF) REPORTS IN COMPLIANCE WITH SECTION 10(4) OF THE B-BBEE ACT AND IN RELATION TO FS100 OWNERSHIP AND FS600 EMPOWERMENT FINANCING OF THE FS CODE FOR THE PERIOD BETWEEN 1 DECEMBER 2020 TO 30 NOVEMBER 2021

The FSTC hereby issues a notice for the submission of reports in accordance with Section 10(4) of the B-BBEE Act of 53 of 2003 and FS000, paragraph 8.4 of the FS Code which requires financial institutions to report annually to the FSTC. This notice is in relation to reporting on the performance of the **Banks and Life Assurers** on BBGF in accordance with the provisions of FS100, paragraphs 2.1, 2.2, and 3.9.1.2 (BBGF under Ownership) and FS600, Empowerment Financing (EF) paragraphs 2.1 and 2.2 (BBGF under EF) for the period between 1 December 2020 and 30 November 2021.
